WHAT DATA DO WE COLLECT?

Our Company collects the following data:

Personal identification information (Name, email address, phone number, etc.) when you contact us directly

General information from Analytics providers such as Google based upon your browsing history such as demographic, geographic and sometimes preference details

HOW DO WE COLLECT YOUR DATA?

You directly provide Our Company with most of the data we collect. We collect data and process data when you:

HOW WILL WE USE YOUR DATA?

HOW DO WE STORE YOUR DATA?
